With Reference to Vedanta Notice Inviting Offer (NIO) dated 21st October 2022 for Sales of Natural Gas from CB/OS-2 block, following revision is provided with respect to Section D - Gas Sales Agreement:

S. No.	Clause of GSA	Revised GSA Provision
1	Clause 3 Start Date and Duration	3.4 At the sole option of the Sellers, the tenure of the Agreement may be extended for an additional period of upto 3 months or 30th April 2023 whichever is earlier ("Extended Period"). During this Extended Period, the DCQ will be between 50%-100% of Awarded Sales Gas Volume or as may be notified by the Sellers to the Buyer to this effect by 21 st December 2022 to which Buyer shall convey acceptance no later than 7 days from the date of notification from the Sellers. All other terms and conditions under this Agreement shall remain same during the Extended Period. If the Buyer fails to respond within 7 days from the date of notification from the Sellers, the tenure of the Agreement shall expire on End Date.
