### **Notice: Spot e-Auction for TPPs/IPPs for the month of August'22**

TPPs/IPPs seeking supply of washery products from BCCL are hereby informed that BCCL has programmed to conduct **Spot e-Auction for TPPs/IPPs** for the month of **August 22**. To participate in e-Auction, the interested consumers shall have to get themselves registered with service providers namely M/s M. Junction Ltd. Bidders will be eligible after fulfilling the required formalities of such registration and submission of Earnest Money Deposit (EMD). Schedule of coal value deposition would be as under:

Spot e-Auction for TPPs/IPPs for the month of **August 2022** will be conducted as per the "Terms & conditions of Spot e-Auction scheme 2007" with all modalities circulated by Coal India Limited. Additionally, **the modified modalities for Spot e-Auction for the month of August 2022 will be as follows:**

1. As per guidelines issued by MoC regarding policy for handling and disposal of washery rejects, successful bidders of washery rejects in this e-Auction shall gainfully use rejects as source of energy in Thermal Power plant for generation of Power with valid environmental clearances/permits for its use.
2. Bidders are required to **submit to service providers (M Junction)** valid environmental clearances/permits for gainful use of rejects as source of energy in Thermal Power plant for generation of Power with valid environmental clearances/permits for its use for participation in this auction.
3. The loading of Rejects rakes under this e-Auction shall be subject to approval of Coal Controller Organization (CCO).
4. Power Plant Consumer may book slurry and rejects in suitable proportion as per their boiler specification and arrange the process of blending for end use on trial basis under this limited offer.
5. The offer for sale of washery products from Bhojudih washery will be under RCR mode. The transportation from stock to siding & loading into the wagons will have to be arranged by successful bidder through own arrangement and the tax invoice shall be prepared based on electronic print of Rail weighbridge.
6. Any penalty charged by Railways viz. demurrage, under loading etc. will have to be borne by successful bidders.

7. Loading of rakes to be completed within free loading time provided by Railway. Co-User charges would be applicable as follows (BCCL reserves the rights to make amendments in Co-user charges without assigning any reason whatsoever)
  - i) Co-user charges if the rake is loaded within free loading hour notified by Railway @ Rs. 30/ tonn + GST
  - ii) Co-user charges if the rake is loaded up to 2 hrs. beyond free loading time @ Rs. 50/ tonn + GST
  - iii) Co-user charge if the rake loading time is more than (ii) above @ Rs. 100/ tonn + GST
8. The statutory levies, namely:- Roylty @ 14% of Bid price, DMFT @ 30 % of Roylty, NMET @ 2% of Roylty, Management Fee @ Rs. 1/tonn, Evacuation Charge @ Rs. 60/tonn, STC, Bazaar Fee @ 1 % of Bid price, GST, GST cess etc. shall be levied wherever applicable.
9. Successful bidders should ensure that they have a valid dealer Registration No. in JIMMS Portal i.e. FORM B and they should submit the same in BCCL of issuance of Sale order.
10. Bid price will be expressed in terms of percentage premium over Notified Price on the date of bidding. Percentage premium will remain constant throughout the lifting period of the e-Auction.
11. Bid Price will be subject to revision with the changes in Notified Price of coal if any. Revised Bid Price will be calculated by adding percentage premium over the revised Notified Price prevailing on the date of supply.
12. Change in Bid Price will only be upward in nature i.e. only upward Notified Price revision will be considered. In case of downward revision in Notified Price, the bid price at the date of bidding will prevail at the time of supply.
13. Successful bidders buying coal/coal products for own consumption are required to mail their scanned copy of form 27C to [eauction.bccl@coalindia.in](mailto:eauction.bccl@coalindia.in) on the next working day of Spot e-Auction along with Sale intimation letter received from service provider for availing TCS exemption.
