Coal distribution through Exclusive **e-Auction** is only for coal consumers who wish to have an assured supply over a long period through e-auction mode. Detailed procedure of registration for participating in Exclusive **e-Auction** is given below:

Step I:

First the intending buyer has to register with us at (www.coaljunction.in) as per the existing registration procedure, details given in link: **New Users : register here** .The **User - Id & Password** would be activated on receipt of following documents & registration fee (Detail Fee structure given on Page 4)

- Self Attested copy of PAN Card
- Photocopy of Sales Tax certificate / Trade License
- Banker's Certificate for Address Proof
- Authorisation letter with 2 latest passport size photograph of Authorized signatory on Company

- Statement of Interest, Training Confirmation Form, & Buyer Identity Card Form. Please print, fill the details and submit it at mjunction's Office, Kolkata or our representative at the Road Show.

Step II:

Online Form fill up by registered buyers (Consumers only):

1. Log on to our website www.coaljunction.in
2. Log in typing your User-Id & Password
3. In the Menu bar go to **'My Profile'** & fill up the the details under the link **'Consumer Documents'**

Step III:

All consumers of coal located in India (viz. Proprietorship/partnership, firm registered in India, companies incorporated in India etc.) desiring supply over a long period can participate in Forward e-Auction for procurement of coal for own consumption and not for transfer or re-sale. The consumer has to furnish the copy of the following documents duly **notarised** as per the CIL Terms & Conditions to junction for necessary verification before activation of consumer status.

Along with the mentioned documents the applicant needs to send an one time 'Document Processing Fee' (Non Refundable, Non Interest Bearing) of **Rs. 3540/-** in the form of Pay Order/DD in favor of '**mjunction services limited A/c Coal**', payable at **Kolkata**.

Note: "All are hereby informed that mjunction doesn't deal with physical currency notes for any services/ product offerings. The consumer / bidder will be responsible for ensuring to keep the registration valid, and for the purpose, the consumer / bidder will keep all the documents mentioned above valid throughout the period right from bidding upto completion of lifting. In the event of expiry of any of these documents, the registration will automatically become dormant and during the period of dormancy, the consumer / bidder will not be allowed to participate in bidding by mjunction and release of coal will be kept suspended by the Coal Company. Such suspension of release of coal will be treated as a failure on the part of consumer / bidder and the proportionate EMD equivalent to the failed quantity shall be forfeited. The registration will however be restored by mjunction and thereafter participation in the bidding will be allowed after submission of the valid document(s) / extension of the validity of the document(s) and coal releases / lifting will be allowed by the Coal Company.

mjunction will also remain vigilant and monitor the validity of all the documents and disallow the consumer to participate in bidding in case any of his documents becomes invalid.

After registration, all consumers / prospective bidders will have an auto-generated Unique User ID and a Password which will be same as Spot eAuction User ID and a Password based on which they can log in on mjunction's web site.

The consumers / prospective bidder must get themselves registered with an approved certifying agency and obtain digital signature for their authentication / proving genuineness which would enable them to participate in e-Auction. The consumers / prospective bidders are required to contact mjunction in this regard for clarification and guidance, if required by them.

Only one registration will be done against one PAN number. However, for more than one coal consuming unit, having independent valid sales tax / VAT registration, more than one registration against one PAN Number can be considered. In such cases, the details of valid sales tax / VAT registration **against each consuming unit** will be indicated in each 'Photo Identity Card'. In the event of one PAN number and one sales tax /VAT registration number is same for a consumer having multiple units in one state, more than one registration will be allowed based on independent valid excise registration number or factory license for such units and the same will be indicated in each "Photo Identity Card".
