- ALL SELECTIVE LOADING IRRESPECTIVE OF MEANS OF LOADING AND MODES OF DISPATCH TO BE CONSIDERED AS LOADING OF STEAM SIZED COAL OF +25 MM. THEREFORE , IN CASE OF SELECTIVE LOADING , A STEAM SIZING CHARGE, WHICH IS PRESENTLY RS. 270/- PER TONNE, BE CHARGED ON THE ROM PRICE ON ACCOUNT OF SIZING.
 - IN ADDITION TO ABOVE , BENEFICIATION CHARGE BE LEVIED FOR ALL SELECTIVE LOADING . THE BENEFICIATION CHARGE BE THE PRICE DIFFERENCE AS PER THE GRADES IDENTIFIED IN THE GRADE NOTIFICATION OF THE COAL COMPANY FOR STEAM AND ROM RESPECTIVELY.
 - THE SELECTIVE LOADING CHARGE FROM THE ROM BE THE SUMMATION OF THE SIZING CHARGE i.e. RS. 270/- PER TONNE AND THE DIFFERENCE OF PRICE ARISING OUT OF THE GRADES OF STEAM AND ROM.
 - THE ROM(-250 MM) COAL OFFERED UNDER RAIL MODE SHALL BE CHARGED WITH 'OPPORTUNITY COST' OF RS.87/- PER TONNE PLUS TAXES AS APPLICABLE.
 - PARTICIPATION OF AUCTION CONSUMERS IN THE BIDDING PROCESS THROUGH THIS NOTICE WILL MEAN THAT THE BIDDER ACCEPTS AND AGREES FOR ALL THE TERMS AND CONDITION OF SCHEME AS WELL AS THIS NOTICE IN TOTALITY .

- A) Such e-Auction consumers must have proper arrangement of dust suppression and other related works along their transport route beyond leasehold area of CCL.
 B) Such consumers will be solely responsible for all hazards, accident, consequences arising out violation of EMP/ factory/ Labour Laws or of any other laws at the time being enforced or due to bandhs/ calls by political or other organizations whatsoever and CCL shall not have any responsibility or liability arising thereof.

- Auction shall be conducted on the Floor price i.e. Reserve price for each source/lot.
- Bid Price shall be expressed in terms of percentage premium over notified price on the date of bidding. Percentage premium will remain constant throughout lifting period of the particular Spot e-Auction.
- Bid Price shall be subject to revision with the changes in notified price of coal if any. Revised bid price shall be calculated by adding percentage premium over the revised Notified Price prevailing on the date of supply.
- Change in bid price shall only be upward in nature i.e. only upward notified price revision shall be considered. In case of downward revision on notified price, the bid price at the date of bidding shall prevail at the time of supply.
