### Notice to all e-Auction Buyers drawing coal by road from NCL

It is to once again notify that applications alongwith payment either by RTGS or by Demand Draft are to be submitted by successful bidders within the validity time frame i.e. within 7(seven) NCL working days after closure of e-Auction between 3PM to 5 PM (Monday to Friday) and 11 AM to 1PM (Saturday).

In case of payment through RTGS, payment should be credited in NCL a/c. within the stipulated period / time. NCL management will not be responsible for any failure / delay in materialization of RTGS.

It may also be noted that in case of payment through RTGS, e-Auction buyers are also required to submit their application alongwith documents including debit advice within the stipulate period / time.

In case of non-compliance of either of the above two conditions, the application will be liable for rejection for which concerned e-Auction buyer will themselves be solely responsible.

In case of payment through Demand Draft the application alongwith demand Draft and other documents including debit advice should be submitted within the stipulated time / period.

It may be further noted that after submission of applications even if completed in all respect, will not be entertained beyond day to day working hours.

As such e-Auction buyers in their own interest must ensure compliance of the above immediately after completion of e-Auction rather than wait for submission of their application and payment on the last day / hour for acceptance of the application.

In case of failure to comply with the above, no individual complaint will be entertained and given any cognizance.
