The modalities for Special Forward e-Auction for Power Producers-2016-17-Phase-IV will stand modified to following extent:-

- Bidders will have to bid source-wise and grade-wise quantity in aggregate and validity period of lifting against the successful quantity **shall be up to 31<sup>st</sup> March'2017**.
