In line with the above, the modified modalities for Special Forward e-Auction for Power Producers-2018-19-Phase-III will be as follows:-

- Bidders will have to bid source-wise and grade-wise quantity in aggregate and validity of each Sale Order will be **45 days**.
- Bidders shall have to give declaration regarding distribution of quantity in **three months period i.e. from Aug'18-Oct '18** within **7 (seven) days** of auction. In case of non-submission of the same, bid quantity will be distributed in equated monthly installments for three month period.
