The successful bidders of coal through **Road mode** shall have to remit full coal value through NEFT/RTGS in favor of "SECL Coal Sale Realisation, A/c---"Name of Customer" payable at Bilaspur (C.G) directly at the Office of the GM(S&M), SECL, Bilaspur.

The successful bidders of coal through **Rail mode** shall have to remit full coal value through NEFT/RTGS in favor of "South Eastern Coalfields Ltd, Kolkata" payable at Kolkata directly at SECL, 13, R. N. Mukherjee Road, Kolkata. This may be noted that the total quantity per rake will be 4071 (69 MT*59 Boxes as per Railway Rules) for calculation of financial coverage.

The successful bid quantity of a bidder for the period (**Feb'16-Mar'16**) would be divided into two parts for determining monthly scheduled quantities (MSQ) for coal supplies during the period. **This division may be as per bidders' choice.**

As per modification in clause 9.1.11 of Terms and Conditions of exclusive e-auction scheme vide above referred letter of GM(S&M), CIL " The supply/booking schedule for the first month as well as second month may have variation and may be notified by the subsidiary coal companies separately...".

Accordingly, coal value against the booking for the month of **Feb'15** may be deposited within 10 working days (of SECL) from date of above e-auction and by the 10th of Mar'16 for supply for the month of Mar'16.

The **Validity period of lifting of coal** by **road mode** shall be **up to 31st May 2016** for the sale/delivery orders issued under this scheme during the months of Feb'16 and Mar'16 provided the coal value is paid against the bid quantity in due time.

It may be noted that the qualified bidders shall be required to submit an additional affidavit (as per prescribed format available on SECL's website) affirming that coal will be utilized for their EUP only, along-with application for booking for each month.
