2. That I have read and understood the e-distribution Policy of WBMDTC Ltd. and also

3. That I confirm and accept the renewal of the Fuel Supply Agreement between
my/our company and WBMDTCL for the year FY 2014-15as per the Terms &
Conditions of the e-distribution Policy of WBMDTC Ltd and also the Terms
and Conditions of the Fuel Supply Agreement of WBMDTCL with ECL for the
year FY 2014-15.
4. I do hereby undertake that in case my/our Factory/Works is closed
and/or does not consume coal supplied for whatsoever reasons,
WBMDTCL will be informed by me in writing within seven (7) days,
without fail, to enable them to discontinue supply of coal to our
Factory/Works.
5. That I have authorised _____(Name of authorised person)
as my authorised representative to do all such acts, deeds, and things
including signing any papers/ documents as are necessary and incidental
to obtaining coal from WBMDTCL under the FSA through a GENERAL
POWER OF AUTHORISED PERSON Dt. _____(Date of
the Document).
6. In addition to the acts and deeds mentioned in the said
"AUTHORISATION", the authorised person is further authorised to

appoint "Lifting Agents" for lifting coal from ECL collieries against my allotment and do all such acts, deeds, and things including signing any papers/ documents as are necessary and incidental to the above AND that any act or statement or writing of my said Authorised Person in pursuance hereto shall be fully authorised and ratified by me.

7. I undertake the responsibility that the entire quantity of coal lifted from ECL collieries by the Lifting Agents against my allotment will be delivered to my/our unit for our own consumption and will not be re-sold or traded.
8. That I / shall be fully responsible for misuse of coal/diversion of coal and WBMDTCL / Concerned authorities will be at liberty to take necessary action as per law. Any diversion or misuse, if found prima facie by any authority, then the coal supplies will be suspended by WBMDTCL with immediate effect and further action for terminating the FSA can be taken.
9. I declare that in case any discrepancy is detected with regards to coal received and coal consumed thereof as well as with respect to statements made hereinabove and in the FSA ; the competent authority of WBMDTCL will have the right to discontinue coal supply at once and take action in accordance with law and the clauses of Fuel Supply Agreement (FSA) without giving any prior notice to me or my factory/works.
