Subject: Change in Capacity of End Use Plant under Auction of NRS coal linkages Tranche-VII for Cement subsector

In order to provide a scope to the interested registered Bidders of **Cement subsector** under Linkage Auction (non-regulated sector) tranche VII to revise the capacity or any other relevant details of their End Use Plants (EUP), a 3-days window from 11.01.2024 to 13.01.2024 shall be available.

- a. - b. Based on the submitted details, necessary updation in the RFP details, if required, shall be made in the new auction platform by the auction service provider, subject to completion of registration process in the new MJ portal. The revised details will be effective from Tranche VII.
- c. All the existing FSAs with the concerned EUP are liable to be amended to reflect the change in capacity/relevant details. The responsibility of intimating such change and submitting the required supporting documents to the concerned coal company will be on the bidder.

The Bidder shall provide all required supporting documents along with revised undertaking and Affidavit and any additional documents requested by the coal company, evidencing the change, at the time of signing amended/revised FSAs.

- d. The Final Normative Coal Requirement of such bidders may be verified by external verification agency post execution of the FSA.
- e. In case it is found at any stage that the bidder has misrepresented any facts, the bidder shall be liable for appropriate/penal action in accordance with the provisions of the Scheme Document/ FSA.
- f. CIL/Coal Company/Auction service provider shall have right to cancel/withdraw such modification requested by the bidder.
