Upon receipt of completed signed and stamped Statement of Interest (SOI Form), above mentioned documents and registration fees, mjunction shall verify the same.

After due verification, the registration would be activated and an email would be sent from mjunction informing the "User-ID & Password" for participating in coaljunction's online e-auctions within 2 working days of receipt of documents.

A Laminated Bidder ID Card would be prepared within 7 days from activation. This ID Card would be sent to you through Courier / Regd Post at your registered address. In case there is a failure in delivery, the registered bidder must collect it, from mjunction office, in person, within 3 (three) months from date of registration, failing which mjunction would bear no liability. A penalty fee of Rs. 590/- would be levied if any registered bidder claims the Bidder ID Card beyond this period of three months and Bidder ID Card would be provided only upon receipt of such fee.

Additional / Duplicate Bidder ID Cards would be provided upon request. A charge of Rs. 590/- per card would be levied.

A Non-Refundable, Non-Interest bearing Registration Fee is to be deposited in favor of "mjunction services limited A/c Coal", payable at Kolkata, to be paid by DD / PO. The Registration Fee Structure is appended below.
