Sub: Increase in rate of Clean Energy Cess renamed as Clean Environment Cess.

Dear Sir,

As per D.O.F. No. 334/8/2016-TRU, New Delhi, dated 29th February, 2016 issued by Ministry of Finance, Government of India, the Clean Energy Cess renamed as Clean Environment Cess has been revised from Rs.200/- (Rupees Two Hundred only) to Rs.400/- (Rupees Four Hundred only) per tonne w.e.f. '00' hours of 1st March, 2016. The relevant portion of the Notification is quoted below:-

Quote:

"The Clean Energy Cess is being renamed as Clean Environment Cess. Also, the Tenth Schedule to the Finance Act, 2010 dealing with Clean Energy Cess is being amended so as to increase the Schedule rate of Clean Energy Cess from Rs.300 per tonne to Rs.400 per tonne. The effective rate of Clean Energy Cess is being increased from Rs.200 per tonne to Rs.400 per tonne. "

This will affect all dispatches of coal including e-auction.
