Sub: Notice for Special Spot e-Auction for Import Substitution (Only for Coal importers) 2020.

Any Indian buyer including traders who imported coal at any point of time in the current year and/or any of the previous two financial years are hereby informed that Special Spot e-Auction for Import Substitution (Only for Coal importers) 2020 is **scheduled to be held on 09.11.2020 through M/s M. Junction Ltd.** Schedule of dates of the said auction is as under:

The **Special Spot e-Auction for Import Substitution (Only for Coal importers) 2020** will be conducted as per the scheme for Special Spot e-Auction for Import Substitution (Only for Coal importers) 2020 notified by CIL vide Notice No- CIL/M&S/SSEA-IMS/268 dated 14.07.2020, Notice No- CIL/M&S/SSEA-IMS/312 dated 12.08.2020 and Notice No-CIL/M&S/SSEA-IMS/423 Dated 05.10.2020. The Basic eligibility criteria for the prospective consumers shall be as per the Special spot e-auction scheme 2020 for Import Substitution. In line with the above, the additional modified modalities for **Special Spot e-Auction for Import Substitution (Only for Coal importers) 2020** will be as follows:-

1. Bidders shall have to give declaration regarding distribution of quantity in **Five months period i.e. from Nov’20- March ‘21** within **7 (seven) days** of auction. In case of non-submission of the same, bid quantity will be distributed in equated monthly installments for Five month period. However, distribution of lifting program can be recast, if needed based on mutual consent of buyer and seller.
2. The minimum quantity for bidding would be 24000 (twenty four thousand) tons for a source for Road mode, where as in case of Rail the minimum quantity for Bidding would be 24000 tons. (twenty four thousand) (i.e. 06 rakes).
3. EMD shall be at the rate of Rs.200/-per tons of all grade coals. EMD can be deposited in form of e-transfers/bank draft/banker’s cheque /bank guarantee.

4. Applicable price on the date of despatch of coal would be variable in line with the changes in the notified price of CIL/BCCL, i.e. the percentage increase over the reserve price at which the bid is clinched, shall be applicable over the revised reserve price arising out of price revision, if any, on the date of dispatch. However, any changes in the methodology/guiding principle for determining the reserve price in subsequent days would not be applicable for revision of current method of determining the reserve price, except for change in the notified price as mentioned above.
