**Exclusive E-auction for Non-Power consumers 2018-19 Phase-III (Jan-Mar '19)** is scheduled to be held on **26.12.2018** in the portal of service provider M/s **M. Junction Ltd.** Schedule of dates of the said auction is as under:

Exclusive e-auction 2018-19 Phase-III will be conducted as per the Exclusive E-auction Scheme of CIL. **The additional modalities for Exclusive E-auction 2018-19 Phase-III will be as follows:**

- Bidders will have to bid for source-wise grade-wise quantity in aggregate. However, bidders after successful bidding will give a declaration to BCCL on distribution of quantity bided in three monthly instalments for **January '19, February '19 & March '19** within **7 days of auction** for despatch by Road. However, distribution can be recasted if needed, based on mutual consent of buyer and seller.
- In case of non-submission of distribution of monthly quantity for **January '19, February '19 & March '19** by the bidders, BCCL will distribute the booked quantity in equal monthly instalments for 3 months for Road and Road/RCR mode.
- For each value paid, separate Sale/Delivery Order shall be issued by BCCL i.e. maximum two Sale Order in each month and the validity period of each Sale order shall be **45 days** in case of road dispatch.
- Bid price will be expressed in terms of percentage premium over Notified Price on the date of bidding. Percentage premium will remain constant throughout the lifting period of the e-Auction.
- Bid Price will be subject to revision with the changes in Notified Price of coal if any. Revised Bid Price will be calculated by adding percentage premium over the revised Notified Price prevailing on the date of supply.
- Change in Bid Price will only be upward in nature i.e. only upward Notified Price revision will be considered. In case of downward revision in Notified Price, the bid price at the date of bidding will prevail at the time of supply.
- Payment of coal value for supply in a month to be made on monthly basis in two instalments as per bidder's choice. Schedule of coal value deposition would be as under:-
