9. ALL SELECTIVE LOADING IRRESPECTIVE OF MEANS OF LOADING AND MODES OF DISPATCH TO BE CONSIDERED AS LOADING OF STEAM SIZED COAL OF +25 MM. THEREFORE , IN CASE OF SELECTIVE LOADING , A STEAM SIZING CHARGE, WHICH IS PRESENTLY RS. 270/- PER TONNE, BE CHARGED ON THE ROM PRICE ON ACCOUNT OF SIZING.
10. IN ADDITION TO ABOVE , BENEFICIATION CHARGE BE LEVIED FOR ALL SELECTIVE LOADING . THE BENEFICIATION CHARGE BE THE PRICE DIFFERENCE AS PER THE GRADES IDENTIFIED IN THE GRADE NOTIFICATION OF THE COAL COMPANY FOR STEAM AND ROM RESPECTIVELY.
