Sub: Exclusive e-auction window for non-power consumers (including CPPs)

Dear Sir,

Under Secretary to the GOI, MOC conveyed the approval of the competent authority for opening a separate e-Auction window exclusively for End Use Plants (EUPs) of Non-Power Sector for a quantity of 4MT vide letter no.23011/56/2015-CPD dtd. 15th September 2015 (copy enclosed). Accordingly, the existing forward e-auction scheme, which is also meant for end users only, has been modified to evolve "Exclusive e-auction Scheme 2015 for Non-Power consumers". The proposal and the scheme incorporating the modifications have been approved by CIL Board in its 320th meeting held on 23rd September '15. Copy each of the scheme and Agenda detail of Board as approved is enclosed.

Exclusive e-auction scheme will be operated basically on the lines of existing "Terms & Conditions of e-auction 2007 for Forward e-auction". All non-power consumers of coal located in India (viz. Proprietorship/partnership, firm registered in India, companies incorporated in India etc.) can participate in the scheme which is for balance period of the year 2015-16.

Exclusive e-auction will be carried out by the two existing service providers i.e. M/s MSTC Limited and M/s mjunction services limited under the existing terms and conditions.

The source, mode and grade of coal will be decided by coal companies as per existing system of forward e-auction and will be duly notified.

An additional affidavit shall be submitted by the qualified Bidders to the subsidiary coal companies affirming that coal will be utilized for their EUPs only, before lifting of coal.

The approved Exclusive e-auction scheme as circulated and the MOC letter no.23011/56/2015-CPD dtd. 15th September 2015 should also be uploaded on the coal company websites.

Subsidiary wise coal allocation for 4MT for Exclusive e-auction based upon offer of Coal Companies is as under:
