

Clarifications to Request for Proposal No. RFP/KGD6/2023/001 ("RFP")

Please refer to RIL and BPEAL's Notice Inviting Offer ("NIO") dated 28 April 2023 and Request for Proposal No. RFP/KGD6/2023/001 ("RFP") for sale of Gas from Gas Fields in Block KG-DWN-98/3 ("KG D6").

Following clarifications are provided pursuant to various queries received from the Bidders on the Request for Proposal No. RFP/KGD6/2023/001 ("RFP") from prospective bidders:

1	(a) In reference to submission of documents related to the eligibility criteria of the Bidder, if the Bidder has obtained such document pursuant to RFP No. RFP/KGD6/2022/001 (Amendment) dated 09 March 2023, then such document shall be accepted provided that if there is any reference of RFP in the document, then it should be suitably modified to RFP No. RFP/KGD6/2023/001. 2	(a) With respect to the clarification sought by CGD entities or other end consumers on resale of unconsumed gas, it is clarified that such CGD entities or other end consumers can resell such unconsumed gas subject to the conditions which may be notified by the Government pursuant to MoPNG notification No. Expl-15022(13)/234/2019-ONG-V (E-33916) dated 13 January 2023 or any other notification. 3	(a) With respect to the extension requests, Bidders are required to refer addendums issued for revised bidding schedule from time to time on the e-Tendering Portal.	Section 6
4	(a) Each interested Bidder (including entities, which have earlier registered on mjunction's portal) is required to do fresh registration on the e-Tendering Portal as specified in Section 7.2.1 of this RFP.	Section 7
5	(a) The Tenure Bid is three (3) years and accordingly, the default value of three (3) years shall be pre-configured in the e-Bidding Portal. Suitable addendum to the RFP is being issued reflecting the above change.	Section 8
