

**Clarifications to GSPA uploaded on 11 May 2023**

11 May 2023

Please refer to RIL and BPEAL's Notice Inviting Offer ("NIO") dated 28 April 2023 and GSPA uploaded on 28 April 2023 ("GSPA") for sale of Gas from Gas Fields in Block KG-DWN-98/3 ("KG D6").

Following clarifications are provided with respect to queries on the GSPA uploaded on 28 April 2023 from prospective Bidders, which shall be read together with GSPA:

1	<p>(a) Within three (3) days from the date of execution of GSPA, Buyer (being a Trader) can notify the Sellers in writing, details of its downstream customer(s) including its captive consumption facility with DCQ of 0.2 mmscmd or above to whom the gas purchased by such Trader under the GSPA shall be supplied. With respect to such Trader, provisions of Clause 14 (Planned Maintenance) and Clause 15 (Force Majeure) of the GSPA shall also be applicable to facility of such notified downstream customer(s) or captive consumption facility to the extent of its DCQ provided that any Planned Maintenance of such downstream customers shall not start within thirty (30) days period from the date of such notice.</p> <p>(b) Within three(3) days from the date of execution of GSPA, if requested by Buyer (being a urea manufacturer or aggregator nominated by DoF for fertilizer units), Buyer can designate up to an aggregate of thirty (30) days of Planned Maintenance for Buyer's Facilities (or downstream fertilizer unit in case of DoF nominated aggregator) or Transporter's Facilities during each Contract Year in which case Sellers can also designate Planned Maintenance of up to thirty (30) days for Seller's Facilities. Such Planned Maintenance shall be scheduled in accordance with provisions of Clause 14 of the GSPA.</p>	Clause 14 & 15: Planned Maintenance & Force Majeure

2	<p>(a) If required by the Buyer, Buyer may notify the Sellers on or before 31 May 2023 its DCQ for the month of June &amp; July 2023 as under:</p> <ul style="list-style-type: none"> <li>i. <b>For June 2023:</b> not lesser than 80% of the GSPA Quantity determined in e-Bidding</li> <li>ii. <b>For July 2023:</b> not lesser than 90% of the GSPA Quantity determined in e-Bidding</li> </ul> <p>(b) Capitalized terms and abbreviations used in this Clarification dated 11 May 2023 shall have the same meanings as set forth in the RFP &amp; GSPA.</p>	General Clarification

All queries have been reviewed and relevant clarifications/addendums have been issued. Except the addendums and clarifications as notified, all other terms and conditions of GSPA remain unchanged. In case of any conflict between the clarifications and GSPA uploaded on 28 April 2023, the provisions of the GSPA uploaded on 28 April 2023 shall prevail.
