NOTICE

Rates of "Chhattisgarh Transit Forest Produce Rules, 2001" has been revised from Rs. 7.00 per tonne to Rs. 15.00 per tonne respectively and is applicable to all dispatches/lifting from 00.00 Hrs of 01.07.2015 as per note sheet No. SECL/BSP/A.A/Note/2015/981 dated 15.09.2015 of Dy.GM (Legal), SECL containing directives of GM (F), SECL.

New rates will be reflected in Delivery Orders itself from spot e-Auction to be held on 18.09.2015 onwards, like-wise in release orders issued to Power Sector Consumers through washery circuit for the month of Oct'15 onwards, the delivery orders against all the other FSA consumers (erstwhile Core, Non-core, State Agencies, IPP etc.) where month of booking is Sept'15 onwards, and similarly in the delivery orders against Forward e-Auction where month of booking is Nov'15 onwards.

Balance amount for Delivery Orders being issued reflecting old rates will be collected at Area Level.

AFM/ASM are advised to check/verify about the revised rate and collect the balance amount / adjust the quantity, as the case may be, if the revised rates is not taken in the amount in Delivery Orders.

If amounts are being paid by the customers, then it must be paid in the form of RTGS in favour of SECL Coal Sale Realization A/c, Bilaspur only. Parties must submit their applications alongwith RTGS details to the Area alongwith form 27C (in Duplicate, if applicable) or add 1% extra in lieu of TCS with every single RTGS. RTGS must not be clubbed for multiple D.O's. In no case DD is to be accepted. RTGS details on being forwarded by Area to SECL HQRs., Bilaspur, necessary confirmation / credit will be sent to Area after verification.
