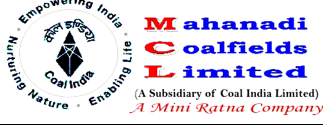

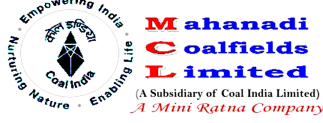
NOTICE

**Subject : Modalities for Special Forward e-Auction for Power Producers
(Excluding CPPs) - 2019-20- PHASE-VI (MAR 2020-MAY 2020).**

The Special Forward e-Auction for 2019-20 for Power Producers (Excluding CPPs) - PHASE-VI (MAR'2020-MAY'2020) will be conducted as per the terms and conditions followed for *Special Forward e-Auction for 2019-20 Phase-V* and as per the *Scheme of Special Forward e-Auction for Power Producers*. However, the modalities for Special Forward e-Auction 2019-20 – PHASE-VI (MAR'2020-MAY'2020) will stand modified to the following extent:

1. The reserve price for power sector consumer will remain at 20% over the notified price of coal for Power sector . This however, is applicable to G6 and below grade of coal.
2. Bidders will have to bid for Source-wise grade-wise quantity in aggregate and month wise coal value to be deposited as per extant practice.
3. The successful bidders have the option of choosing the monthly quantity for the period of auction i.e. March'2020 to May'2020. For Road mode, **the lifting validity of all the RDOs to be issued against the MSQ of March & April'2020 shall be up to 31st May'2020.The validity period for lifting of coal shall be 45 days beyond 31.05.2020 against the quantity allocated for May'20 (Last month of 3 month auction period) subject to deposition of coal value.**
4. The successful bidders, after winning bid quantity in the auction, shall have to give a declaration to MCL, distributing the aggregate quantity between March'2020 to May'2020 (3 months) within 7 days of auction. However, the distribution of lifting program can be recasted if needed based on mutual consent of buyer and seller.
5. In case of non-submission of the said distribution of quantity by the successful bidders, MCL will distribute the quantity booked in 3(Three) equal monthly installments for the month March'2020 to May'2020.
6. In case of Road mode, the successful bidder will be required to deposit coal value for the scheduled quantity of March'2020 by **31st March,2020** and the total coal value payment against the scheduled quantity of April'2020 has to be made by **16th April'2020** so that to allow clear **45(forty-five)** days for lifting of booked quantity of coal after issuance of delivery/sale order. For the MSQ of **May'2020** coal value required to be deposited in by 31st May 2020 so that RDO can be issued within the same month. The RDO will be issued only after receipt of 100% coal value against the monthly scheduled quantities.
7. In case of booking under **Road-cum-Rail(RCR)** mode **the additional modalities applicable** is as under :
 - Bidders may bid for quantities offered in both Road and Road-cum-Rail (RCR) mode, as per their requirement. As at least, around 4000 tonne is required for formation of a rake, the minimum quantity for bidding by RCR mode is kept at a round off quantity of 4000 tonne and in multiple thereafter.

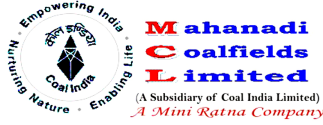

- The quantity allotted against each rake is only indicative; however delivery shall be made on the basis of actual weighment by the seller at the loading point.
- The successful bid quantity of a bidder for the period (operative months) would be divided in equal parts for determining Monthly Scheduled Quantities (MSQ) for coal supplies during the period. However, in case of supply by RCR, such equal monthly parts shall be in the multiple of rake load. The total successful bid quantity in rake loads for the period for a bidder shall be distributed equally over the operative months of the period. In the event the total quantity is not exactly divisible by no. of operative months, the fractional quantity of either one or two rakes above the multiple of no. of operative months (3 months), will be programmed in the 1st or 2nd month of the period as the case may be. For example, if a successful bid quantity is 10(Ten) rakes for a bidder in a quarter, after allocating 3(three) rakes per month of the period; the remaining 10th rake will be programmed in the 1st month of the period. Similarly, in the event of successful bid quantity being 11 rakes in the period for a bidder, the monthly allocation would be in the order of 3(three) rakes per month in the period and the remaining 10th and 11th rake will be programmed for 1st and 2nd month of the period respectively and so on.

However based upon the availability of coal at different sources and time span the monthly programme/lifting plan, if required, may be recasted by the consumer with the consent of MCL in advance.

- Although loading in Rake will be the responsibility of MCL, but to avoid any complaint regarding over-loading, under loading and for quality, the Buyer himself or his authorized representative may supervise loading at the loading point. The authorized representative must carry valid authority letter along with photocopy of Identity Card issued by the Service Provider to the consumer. The overloading and under loading charges, if any, at the rates applicable as per Railway rules, will be entirely borne by the respective Buyer / bidder only. The weighment at the Rail in motion weighbridge shall be final and binding for all commercial purposes. Further, Demurrage/any other charges levied by Railways shall borne by the Buyer / bidder.
- Based on the successful bid quantity, one or multiple siding(s) among Spur-7 & 8, Siding No. 9 and Bharatpur Silo siding shall be notified by MCL within 7 days after the day of auction. The decision of MCL in this regard shall be final and binding.
- The bidder-wise monthly schedule quantity shall be intimated by Road Sales Section , MCL HQ to Hingula area based on the advance payment deposited by the successful bidder.
- The successful bidders shall provide list of vehicles fitted with GPS and identifiable markings at the area for commencement of transportation of coal to siding allotted by MCL after bidding. Only hyva/ tipping trucks painted with fluorescent colour shall be allowed for transportation of coal to sidings by consumers. The consumers shall not engage vehicles for this purpose which are already in use by different transporters for transporting MCL coal to sidings

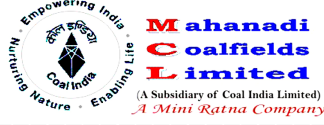

- Coal shall be loaded into the vehicles deployed by the successful bidders through their pay loaders for onward transportation to siding. Successful bidders shall make their own arrangement for loading and transportation from mine end to assigned railway siding.
 - Weighment shall be taken at both the mine end and also at the road WB at siding at the receiving end. MCL shall not be responsible for any transit loss during transportation from mine end to siding. The weighment at the receiving end shall be final for book keeping of stock at the siding. However, where there is no weighbridge at receiving end, the weighment at the loading point shall be considered for book keeping of stock. Any transit loss between loading end and receiving end will be billed to the bidders as difference in weighment. Any excess weighment in the rake than the received quantity at siding shall be billed extra at the bid rate.
 - Based on the intimation of availability of coal at siding, MCL shall place specific indent for allotment by Railways. The allotment shall remain valid as per the extant Railway rules. The total number of indents shall not exceed total number of rakes for which payment has been received. The weighment at Rail In-motion weighbridge shall be final however, if the Rail in-motion WB shall be out of order at the time of weighment, the final invoice shall be raised on the basis of RR quantity.
 - Coal Value along with EMD will be refunded to the extent residual coal lying at MCL siding (s) less than one rake load. In such cases consumers will not claim any charges on account of transportation of the residual coal. However in case of consumer will fail to transport the bidden quantity within the stipulated/validity period to siding, the EMD of the proportionate quantity shall be forfeited.
 - The standard operating procedure regarding 3rd party sampling shall be extended to the successful bidders as per the CIL policy
 - The consumers shall not be charged STC to the extent the transportation is done through the vehicles deployed by the consumers. However, STC for face to stock/pit head shall be charged as per the current slab applicable. The Evacuation Facility Charge will be levied as per CIL guidelines. Rapid Loading Charge if any shall be levied wherever applicable as per CIL guidelines. The other statutory/non-statutory charges shall be charged to consumers as applicable.
 - Apart from the coal value as per the bid price, an additional siding facility charge of ₹20/- (Rupees Twenty Only) per tes plus GST, as applicable, shall be levied to successful bidders for using MCL siding(s).
8. Registration of the bidders & Submission of EMD in the form of Demand Draft /Banker's cheque/RTGS/BG may be made following the notice of schedule of dates which will be published in website of MCL/Service Provider. Bidders who have already registered for participating in the earlier phases of Special Forward E-auction and Special E-auction conducted earlier, shall be eligible to participate subject to deposition of required EMD.

9. Bidders who have applied for CTO : The bidders who has applied for renewal of CTO of the respective plant and yet to receive the valid NOC from the respective State Pollution Control Board is required to furnish the proof of application to the State Pollution Control Board along with an affidavit declaring that the copy of Original Certificate will be submitted within 3 months from the date of expiry of CTO or validity period for lifting coal whichever is earlier. However, the bidder along with proof of application to the State Pollution Control Board needs to submit the copy of affidavit, duly notarized, if it is already submitted for participating in the earlier phases of Special Forward e-Auction.

Bidders who have yet to apply for renewal of CTO which will expire during the pendency of lifting: Those bidders shall have to submit an undertaking (in form of affidavit duly notarized) stating that they will submit the copy of application documents for renewal of CTO to the respective State Pollution Control Board and the original CTO will be submitted within 3 months from the date of expiry of the CTO or end of validity period for lifting coal whichever is earlier.

10. In case of deposition of security deposit in the form of BG, the successful Bidder shall be depositing applicable full coal value against the Monthly distributed quantity. The BG shall remain as security with coal company, in case of default in lifting the coal company shall encash the applicable amount from the BG giving 10 days notice to the Successful Bidder, in case the amount under encashment is paid by the Bidder within 10 days the BG shall not be encashed. Otherwise, The BG shall be encashed in full irrespective of amount of forfeiture . However, the bidder shall have the option to deposit fresh BG to take back the security deposit available with coal company . In case of non deposition of fresh BG, the encashed amount will remain as cash security deposit to coal company.
