Sub : Modification in the Spot e-Auction Scheme 2007 and Forward e-Auction Scheme in respect of registration procedure .

This is with reference to the procedure of registration of bidders for participation in Spot e-Auction Scheme 2007 and forward e-Auction Scheme introduced by CIL in terms of New Coal Distribution Policy.

In order to encourage wider participation in e-auction of coal the following modification in the schemes has been approved by competent authority .
