Bidders shall have to give declaration regarding distribution of quantity in **two months period i.e. from January'17 - February'17** within 7 days of auction. In case of non-submission of the same, bid quantity will be distributed in equated monthly installments for two months period. However, distribution of lifting program can be recasted, if needed based on mutual consent of buyer and seller.
