**SCHEDULE & MODALITIES FOR SPECIAL FORWARD E-AUCTION FOR POWER
PRODUCERS-2016-17-PHASE-VIII**

It is for information of all Power producers (excluding CPPs) that Special Forward E-Auction for Power Producers-2016-17-Phase-VIII is scheduled to be held on **31st March'2017 through M Junction Limited.** Schedule of dates for the said auction is as under:-

The Special Forward e-Auction for Power Producers- Phase-VIII will be conducted as per the scheme of Special Forward e-Auction for Power Producers and on the following terms & conditions :-

1. Applicable price on the date of despatch of coal would be variable in line with the changes in the notified price of CIL, i.e. the percentage increase over the Reserve Price at which the bid is clinched, shall be applicable over the revised Reserve Price arising out of price revision, if any, on the date of dispatch. However, any change in the methodology/guiding principle for determining the reserve price in subsequent days would not be applicable for revision of current method of determining the reserve price, except for change in the notified price as mentioned above.
2. Year-wise quantity of coal would be notified for all three years and consumers may bid for Source-wise grade-wise quantity in aggregate for any period they desire against the consolidated quantity of three years. Successful bidders shall submit a declaration of Year-wise quantity further distributing the quantity in Monthly Scheduled quantity for any period i.e. 1 month, 2 months, 3 months, 6 months, 9 months etc. within 7 days of e-Auction. Consumers are also free to bid coal for any period of time (shorter or longer), for example, they can book/ lift the quantity which has been bid by them in 1 month, 2 months, 3 months or in any time period as specified by them in their schedule for lifting. In case, sum of year-wise quantity declared by all successful bidders for any source is more than the offer notified by CCL for that year, quantity of coal allowed to be supplied to each successful bidder would be distributed in proportion to the quantity bid by such bidders from that source. However, lifting schedule/ quantity can be recast based on mutual consent of buyer and seller, if needed. In case of non-submission of the said distribution of quantity by the successful bidders, CCL will distribute the quantity booked in equal monthly installments for 36 months i.e. 12 months of each year.
3. The successful bidder after Special forward e-Auction will be required to deposit coal value for supply in a month with CCL in two installments as per their choice. First installment to be paid within 10 working days of the respective month and the second installment to be paid within the last working day of the month. However, for any rescheduling of payment by successful bidders for the first month after auction, if needed, CCL may decide the dates for payment.
4. For Road borne lifting, the validity period for lifting of coal for the Sale orders issued in any year shall be last working day of that financial year. Further, the lifting validity of the Sale orders issued against the quota of the last month of the

financial year shall be 45 days beyond 31st March of that year. The EMD would be deducted for un-lifted quantity at the end of each financial year or after the expiry of last Sale order, as the case may be.

5. For Rail supply, validity for taking allotment will be within 30 days of the last date of paying installments of coal value for the month by buyers and supply will be made as per extant Railway rules.
6. EMD applicable shall be 6% of the Reserve price for the total quantity.
7. Tori siding will be provided to the consumers (single or COC) on user charge basis whose bid quantity shall be **3.0 Million tonnes or more for one year** from Magadh or/ and Amrapali offered through RCR (Road-cum-Rail) mode for Tori siding.
8. In case of New Piparwar/ Balumath siding, quantity offered is for the period Apr.'17 to Sep.'17. Hence, payment of coal value in this regard has to be deposited within September'17. Further in case if CCL would not be able to supply coal from New Piparwar/ Balumath sidings, coal would be supplied from RCM siding after competent approval.

Tentative offer in this regard is enclosed.
