**SCHEDLUE & MODALITIES REGARDING SPECIAL SPOT E-AUCTION -2017-18-PHASE-II**

It is for information of all Buyers that Special Spot E-Auction-2017-18-Phase-II is scheduled to be held on **7<sup>th</sup> November'2017 through M Junction Limited.**

The Special Spot e-Auction will be conducted as per the terms and conditions followed for Special Spot e-Auction-2017-18-Phase-I & Scheme for Spot e-Auction of CIL. The basic eligibility criteria for the prospective consumers shall remain as clause I of existing Spot e-auction scheme of CIL. The relevant condition for validity period and schedule of lifting would be as below:-

1. The e-Auction is being conducted for 4 (four) months period i.e. from **November'17 to February'18.**
2. The successful bidder shall have to give declaration regarding distribution of quantity in **four months period i.e. from November'17 - February'18** within 7 days of auction.
3. The successful bidder would be required to make the payment for Monthly Schedule quantity by **10<sup>th</sup> of concerned month** (next working day in case of holiday). For first month i.e. November'17, last date of deposition of coal value would be **20/11/17.**
4. Lifting validity for all month's quota would be **31/03/18.**
