The Special Forward e-Auction for Power Producers-2017-18-Phase-I will be conducted as per the terms and conditions followed for Special Forward e-Auction-2016-17-Phase-VII and as per the scheme of Special Forward e-Auction for Power Producers. The modalities for Special Forward e-Auction for Power Producers-2017-18-Phase-I will stand modified to following extent:-

- 1. Bidders will have to bid source-wise and grade-wise quantity in aggregate and have to give declaration regarding distribution of quantity in 11 (eleven) months period i.e. from May'17 to March'18 within 7 (seven) days of auction. In case of non-submission of the same, bid quantity will be distributed in equated monthly installments for twelve months period. However, distribution of lifting program can be recast, if needed based on mutual consent of buyer and seller. Consumers are also free to bid coal for any period of time (shorter or longer), for example, they can book/ lift the quantity which has been bid by them in 1 month, 2 months, 3 months or in any time period as specified by them in their schedule for lifting.
- 2. The successful bidders will be required to deposit coal value for supply in a month in two installments as per their choice. First installment to be paid within 10 working days of the respective month and the second installment to be paid within last working day of the month.
- 3. For Road borne lifting, the validity period for lifting of coal for the Sale orders issued for the quota till Feb. '18 shall be 31-03-2018. Further, the lifting validity of the Sale orders issued against the quota of March'18 shall be 15-05-2018.
- 4. Tori siding will be provided to the consumers (single or COC) on user charge basis whose bid quantity shall be 2.0 Million tonnes or more from the mines offered.
