

- Competent authority of CCL has allowed for round the clock loading through tipper trucks/ hywa to consumers who book orders for one Lakh tonnes or more and loading through tipper trucks / hywa within agreed timeline of roadsale to consumers who shall book orders for 25,000 tonnes or more from CCL from a source under each e-auction under Road/ RCR mode, if they agree to comply with below mentioned points:-
  - Such e-auction consumers must have proper arrangement of dust suppression and other related works along their transport route beyond leasehold area of CCL.
  - Such consumers will be solely responsible for all hazards, accident, consequences arising out of violation of EMP/ Factory/ Labour laws or of any other laws at the time being enforced or due to bandhs/ calls by political or other organizations whatsoever and CCL shall not have any responsibility or liability arising thereof.
- Auction shall be conducted on the floor price i.e. reserve price for each cluster
- Percentage premium will remain constant throughout lifting period of the particular e-auction.
- Bid price shall be subject to revision with the changes in notified price/modulated price of coal if any and as per relevant clause in scheme document
- Change in bid price shall only be upward in nature i.e. only upward notified price/modulated price revision shall be considered. In case of downward revision on notified price/modulated, the bid price at the date of bidding shall prevail at the time of supply.
- Refund process of sale orders under road mode shall be completed following due formalities of scheme document, within 15 days of lifting validity date
- The consumers taking coal under Rail mode should ensure compliances related with Mining permit, JIMMS portal etc. Related documents like Form-B, Form-H should be made available at siding/mine/Area well in advance for application of Mining Permits. CCL shall not be responsible for any loss in loading on account of delay/non approval of Mining Permit applications by respective DMOs.
