Exclusive e-auction **2018-19 Phase-IV** will be conducted as per the Exclusive E-auction Scheme of CIL. **The modified modalities for Exclusive E-auction 2018-19 Phase-IV will be as follows:**

- Bidders will have to bid for source-wise grade-wise quantity in aggregate. However, bidders after successful bidding will give a declaration to BCCL on distribution of quantity bid for the month of **March '19** in two instalments within **7 days of auction** for despatch by Road. However, distribution can be recast if needed, based on mutual consent of buyer and seller.
- Coal value can be deposited in two instalment for the month of March 2019. For each value paid, separate Sale/Delivery Order shall be issued by BCCL i.e. maximum two Sale Order for the month of March 2019.
- Bid price will be expressed in terms of percentage premium over Notified Price on the date of bidding. Percentage premium will remain constant throughout the lifting period of the e-Auction.
- Bid Price will be subject to revision with the changes in Notified Price of coal if any. Revised Bid Price will be calculated by adding percentage premium over the revised Notified Price prevailing on the date of supply.
- Change in Bid Price will only be upward in nature i.e. only upward Notified Price revision will be considered. In case of downward revision in Notified Price, the bid price at the date of bidding will prevail at the time of supply.
- The booking for the month of March '19 against the successful bid quantities under this e-auction will be valid for lifting up to 45 days from the date of issue of Sale Order or 31st March 2019 whichever is later.
