8. COMPETENT AUTHORITY OF CCL HAS ALLOWED FOR ROUND THE CLOCK LOADING THROUGH TIPPER TRUCKS/ HYWA TO CONSUMERS WHO SHALL BOOK ANY QUANTITY OF COAL THROUGH ROAD/RCR MODE UNDER THIS AUCTION, IF THEY AGREE TO COMPLY WITH BELOW MENTIONED POINTS :-

- A) Such e-Auction consumers must have proper arrangement of dust suppression and other related works along their transport route beyond leasehold area of CCL.
- B) Such consumers will be solely responsible for all hazards, accident, consequences arising out violation of EMP/ factory/ Labour Laws or of any other laws at the time being enforced or due to bandhs/ calls by political or other organizations whatsoever and CCL shall not have any responsibility or liability arising thereof.

9. Tori & Rajdhar (line no.1) sidings of CCL are considered to be offered under this e-auction for evacuation of coal through RCR mode. Detailed terms & conditions for the same are as under:-

- A) Tori & Rajdhar (line no.1) sidings of CCL will be provided to the successful bidders under this Special Forward e-Auction (individual or through forming a consortium) on user charge basis whose total successful bid/ allotted quantity shall be highest in totality from the Magadh, Amrapali & Tetriakhar mines offered under the e-Auction.
- B) Consumers willing to co-use Tori & Rajdhar (line no.1) sidings, either as individual or through forming a COC, will be required to submit their Expression of Interest to CCL within 5 days of e-Auction through e-mail on gmsalesccl@gmail.com followed by submission of hard copy in office of GM(M&S), CCL.
- C) Accordingly, a meeting with the consumers, who would submit their EoI in scheduled time, will be convened within 7 days from the last date of submission of EoI to proceed further for allowing the sidings to be used on co-user basis.
- D) Preference for assigning the siding will be given to eligible successful bidders, individual or COC, having the higher successful bid/ allotted quantity.
- E) While considering the request of siding preference expressed by eligible successful bidders, preference will be given to eligible successful bidders, individual or COC, having the higher successful bid/ allotted quantity.
- F) Both the sidings would be made available by applying the criteria as mentioned at point no. 4 & 5 above to different individual successful bidders/COC having highest successful bid/ allotted quantity in totality from Magadh, Amrapali & Tetriakhar mines offered under the e-Auction.
- G) In case, sidings could not be allotted to any successful bidder (individual or COC), coal will have to be lifted by successful bidder(s) through Road mode/ RCR mode through other Railway good-sheds.
- H) Decision of CCL's management in this regard would be final and binding on all successful bidders (individual or COC).
