## NOTICE FOR BIDDERS/ BUYERS OF COAL UNDER SPOT E-AUCTION

However relevant clauses of the said terms and conditions stand modified as per the guidelines received from GM (M&S), Coal India Limited vide letter ref. no. CIL/M&S/E-Auction/355 date: 15.06.2018:
