The Special Spot e-auction for Import Substitution for 2020-21 will be conducted as per the Special Spot e-Auction Scheme-2020 for Import Substitution (only for coal importers) notified by CIL vide Notice No.-CIL/M&S/SSEA-IMS/268 dated 14.07.2020, Notice No.- CIL/M&S/SSEA-IMS/312 dated 12.08.20 and Notice No.- CIL/M&S/SSEA-IMS/423 dated 05.10.2020. For details the bidders may refer the scheme/notifications which are readily available on CIL's official website [www.coalindia.in](http://www.coalindia.in).

The basic eligibility criteria for the prospective Bidders/consumers shall be as per the Special Spot e-Auction Scheme-2020 for Import Substitution (only for coal importers). The relevant condition for EMD, validity period and schedule of lifting would be as below:-

1. The e-Auction is being conducted for the period from October' 20 to March' 21.
2. EMD shall be at the rate of Rs.200/- per tonnes for all grades coal. EMD can be deposited in form of e-transfers/bank draft/banker's cheque/ bank guarantee.
3. Since the auction is scheduled on ~~29~~ 10.10.2020, the successful bid quantity of a bidder for the period from November'20 to March'21 would be divided in equal parts for determining Monthly Scheduled Quantity (MSQ) for coal supplies during the period. However, distribution of lifting program can be recast, if needed, based on mutual consent of buyer and seller in advance of the last date of payment for the respective month.
4. The successful bidders after said auction will be required to deposit coal value for supply in a month with the concerned coal company in two instalments as per their choice. The First instalment to be paid within 10 working days of the respective month and the second instalment to be paid by successful bidder within the last working day of the month.
5. Validity of lifting of coal under Road mode would be 45 (Forty Five) days from the date of issue of sale/delivery order.
6. Applicable price on the date of dispatch of coal would be variable in line with changes in the notified price of the CIL, i.e., the percentage increase over the Reserve price at which the bid is clinched, shall be applicable over the revised reserve price arising out of price revision, if any on the date of dispatch. However, any change in the methodology/guiding principle for determining the reserve price in subsequent days would not be applicable for the revision of current method of determining the reserve price, except for change in the notified price as mentioned above. Change in bid price shall only be upward in nature i.e. only upward notified price revision shall be considered. In case of downward revision in notified price, the bid price at the date of bidding shall prevail at the time of supply.
7. Applicable Value of Financial Coverage as and when Decided by NCL (towards differential price arising in the event of up gradation pursuant to third party sampling /Referee results ) need to be deposited by the successful bidders opting third party sampling. The financial coverage would be in the form of BG or cash at the option of the bidder.
8. Successful Bidders shall deposit Coal value in any of the following NCL CSR accounts through Draft/RTGS/ECS/Banker's Cheque at the office of General Manager (S&M), NCL Singrauli at the following banks.
