New rates will be reflected in delivery orders itself from current E-Auction i.e. 104th Spot E-Auction for the month of Dec'13 (this includes Spot E-auction held on 16-12-2013 and all subsequent E-Auctions). Successful bidders of 104th E-Auction and thereafter are advised to make the payment through RTGS accordingly within 7 working days from the date of e-auction.

Balance amount in respect of Delivery Orders currently being issued for quantity booked in 103rd and 104th (only for e-auction held on 12 Dec'13) Spot E-Auction will be collected at Area Level. In respect of FSA consumers, AFM/ASM are advised to check/verify about the revised rate of sizing charges and release the balance amount/adjust the quantity if the revised sizing charge is not taken in the amount in the Delivery Orders.

If amounts are being paid by the Customers, then it must be paid in the form of RTGS in favor of SECL Coal Sale Realization A/c, Bilaspur only. Parties must submit their applications along with RTGS details to the Area along with form 27C (in Duplicate, if applicable) or add 1% extra in lieu of TCS with every single RTGS. RTGS must not be clubbed for multiple D.O.'s. In no case D.D. is to be accepted. RTGS details on being forwarded by Area to SECL HQ, Bilaspur necessary confirmation/ credit will be sent to area after verification.
