## NOTICE

New rates of "Clean Energy Cess" @ Rs.100/- per tonne is applicable w.e.f. 00.00 Hrs. of 11.07.2014 vide letter No. SECL/BSP/GM(F)/FM(Tax) dated 10.07.2014 of GM(Fin.), SECL HQRs. (copy enclosed).

New rates will be reflected in Delivery Orders itself from 111th Spot e-Auction for the month of July'2014 (this includes Spot e-Auction to be held on 16.07.2014 and all subsequent e-Auctions). Successful bidders of 111th e-Auction and thereafter are advised to make the payment through RTGS accordingly within seven working days from the date of e-Auction.

Successful bidders under Forward e-Auction should also make the payment for the month of Aug'2014 accordingly within due date.

Balance amount in respect of Delivery orders currently being issued for quantity booked in 110th (e-Auction held on 14th June'2014), Spot e-Auction will be collected at Area level.

In respect of FSA consumers, AFM/ASM are advised to check/verify about the revised rate of Clean Energy Cess and collect the balance amount / adjust the quantity, as the case may be, if the revised Clean Energy Cess is not taken in the amount in Delivery Orders.

If amounts are being paid by the customers, then it must be paid in the form of RTGS in favour of SECL Coal Sale Realization A/c, Bilaspur only. Parties must submit their applications alongwith RTGS details to the Area alongwith form 27C (in Duplicate, if applicable) or add 1% extra in lieu of TCS with every single RTGS. RTGS must not be clubbed for multiple D.O's. In no case DD is to be accepted. RTGS details on being forwarded by Area to SECL HQRs., Bilaspur, necessary confirmation / credit will be sent to Area after verification.

Sub :: Enhancement in the rate of Clean Energy Cess on Raw Coal w.e.f. 11-7-20141

In the Union Finance Budget 2014-15, as tabled by the Hon'ble Finance Minister today(10-07-2014) in the Parliament, rate of Clean Energy Cess has been increased from Rs.50/-tonne to Rs.100/-tonne w.e.f. 11<sup>th</sup>. July, 2014.
