Sub: Amendment in Clause 11.8.3 of CIL e-Auction Scheme 2022

It has been decided by the CIL Management to amend **Clause 11.8.3 (Cash – Financial Coverage)** of the CIL e-Auction Scheme 2022 . Accordingly, the following amendment is hereby issued:

Clause Reference	Existing Provision	Amended Provision
– Financial Coverage)	and Bid Security amount taken together shall be equivalent to the 100% coal value as per clause 6.1 of the scheme. The differential amount as mentioned in 11.8.3 above shall be furnished by Demand Draft/Pay order/e-transfer, referred to as cash prior to signing of trinartite agreement "	per clause 6.1 of the scheme. The differential amount towards Financial Coverage may be furnished either in the form of (a) Demand Draft/Pay order/e-transfer (cash), or (b) Bank Guarantee/e-Bank Guarantee (BG/e-BG) valid for a minimum period of six months or till final cettlement.
